Holyhead Drugs and Alcohol Policy

Introduction

Holyhead acknowledges that drugs have had a long history in society and that experimentation has always been a feature of some young people's lives. It is our responsibility to reduce the harm from drugs and alcohol, play a role in their prevention and help those who misuse drugs and alcohol. This policy gives clear guidelines on dealing with the misuse of drugs and alcohol at Holyhead and the importance of drug and alcohol education. This policy emphasises Holyhead's pastoral role and proactive approach to drug and alcohol education. In developing this policy, Holyhead has considered its legal responsibility and the needs of students, teachers and the local community.

1. A Definition of Drugs

1.1 Holyhead School defines a "drug" as any substance which, when ingested alters perception and the way the body works. This definition includes, but is not limited to:

- All illegal substances
- Alcohol
- Tobacco (vaping pens)
- Solvents
- Medicines
- Legal highs

1.2 The use of such substances at Holyhead is strictly forbidden. School students found in Possession of such substances will be subject to disciplinary measures and risk permanent Exclusion. Parents/carers will be informed and counselling will be offered where appropriate.

Students who need to take regular medication must inform the school's Medical Officer.

2. Key Roles and Responsibilities

The Governing Body is responsible for:

- 2.1 Implementing effective policies and procedures are in place to ensure that students are kept safe from alcohol and drugs at school.
- 2.2 Ensuring that students experiencing difficulties with alcohol and/or drugs can

access the support they need.

- 2.3 Working with the Principal, and in liaison with parents/carers, students, health and other professionals, to ensure that the drug and alcohol curriculum addresses the needs of students and the local community, and reflects current trends.
- 2.4 Ensuring that the Designated Safeguarding Governor submits an annual written report to the Governing Board concerning drug and alcohol related incidents and concerns.

The Principal is responsible for:

- 2.5 Providing a safe environment for all staff, students and visitors.
- 2.6 Working with Governors to ensure compliance with relevant legislation.
- 2.7 Informing the Governing Board, via the designated safeguarding Governor, of any issues and developments concerning drugs and alcohol.
- 2.8 Acting on any concerns arising from students' use of drugs and alcohol.
- 2.9 Ensuring a consistent approach to managing drug and alcohol incidents.

The DSL is responsible for:

- 2.10 Ensuring that staff have the skills to teach and discuss issues relating to drugs and alcohol.
- 2.11 Ensuring that staff and students experiencing difficulties with drugs or alcohol are provided with appropriate internal support and referred to external support agencies as appropriate.
- 2.12 Consulting with students to inform provision around drugs and alcohol education.
- 2.13 Accessing appropriate training to enable them to successfully advise the school on drug and alcohol matters.
- 2.14 Liaising with local services as necessary to provide support for students.
- 2.15 If appropriate, and where doing so will not place the student at risk, informing parents/carers of any drug and alcohol related incidents concerning their child.
- 2.16 Inviting the local police and drugs team into school to raise awareness of the risks and issues associated with drugs.
- 2.17 Informing the police of any drug or alcohol related decision, where they deem it appropriate to do so.

2.18 Assisting with the monitoring and review of this policy.

Students are responsible for:

2.19 Ensuring they do not bring illegal or prohibited drugs or alcohol onto school premises or whilst engaging in any off-site activity representing the school.

2.20 Ensuring they do not take drugs or consume alcohol whilst travelling to or from school or at any time whilst wearing the school uniform.

2.21 Contributing to the development of this policy by providing feedback on the effectiveness of the drugs and alcohol education provided, and on how incidents are managed.

All Staff (both teaching and support staff) are responsible for:

2.22 Attending scheduled training concerning drugs and alcohol, including how to spot the signs and symptoms of use and dependency, identifying paraphernalia and how to respond to a drug related incident.

The Site Manager is responsible for:

2.23 Regularly checking the school premises for signs of drug and alcohol use and reporting any concerns to the DSL.

External Agencies are responsible for:

2.24 Supporting the school with drug and alcohol issues as required.

3. Drug Education and Drug Prevention

3.1 Holyhead provides a comprehensive and planned drug and alcohol education curriculum for all students, as part of health education within the taught Personal, Social, Health and Citizenship Education programme. Further details are available from the Head of PSHCE.

3.2 It aims to enable students to make informed choices by increasing knowledge and challenging attitudes.

3.3 Lessons will be delivered as appropriate to the age of the students and will be differentiated according to individual learning styles.

3.4 Where appropriate, visitors and external speakers will join us to lead classes on drug and alcohol misuse.

3.5 Holyhead acknowledges that a positive ethos helps students to feel valued and part of the community, and in so doing, helps to foster positive self-images which may help students cope better in situations involving drug and/or alcohol use.

4. Disclosure

- 4.1 When a young person discloses to a member of staff that he/she has been using drugs and/or alcohol or is concerned about someone else's drug and/or alcohol use, staff should respond in a supportive manner and should be nonjudgmental.
- 4.2 Staff cannot promise total confidentiality and will refer this to a member of the SPACE (Student Progress and Achievement Centre) team.
- 4.3 Parents/carers will be informed immediately especially if further support is to be considered, such as referral to a counselling service.
- 4.4 Information about the person involved will only be given to a restricted group, unless that person gives their consent. Total confidentiality is maintained at all times in professional counselling services.
- 4.5 All young people at Holyhead need to feel able to talk to a member of staff about a drug related problem without the fear of being judged or reprimanded. The welfare of young people will always be central to our policy and practice.

5. Police Involvement

- 5.1 In most cases, disciplinary action is likely to be a school matter and the police will be informed as appropriate.
- 5.2 The school is aware of the Misuse of Drugs Act 1971, which controls heroin, cocaine, LSD, MDMA (Ecstasy), amphetamines, cannabis and other 'dangerous or otherwise harmful' drugs including alcohol. The Act makes it an offence to possess or supply these drugs.
- 5.3 Holyhead maintains strong links with the local community police. It is our policy to contact our police/school liaison officer when there has been an incident involving illegal substances.

6. Disciplinary Response

- 6.1 Students involved in drug and/or alcohol situations on school premises will be disciplined as Per the school's disciplinary procedure and, where appropriate, the police will be informed.
- 6.2 Teachers and staff members involved in drug and/or alcohol situations on school premises will be disciplined as per their contract of employment and, where appropriate, the police will be informed.

7. Medical Emergencies

- 7.1 In drug related medical emergencies, the school nurse/trained first aiders will be summoned.
- 7.2 A teacher will remain with the casualty until the school nurse/trained first aider arrives.
- 7.3 Other students will be removed from the immediate area, as soon as is reasonably practicable.
- 7.4 Following assessment by the school nurse/first aider, a decision will be made to ascertain whether an ambulance will be called.
- 7.5 The student's parents/carers will be telephoned and told about the incident.
- 7.6 If the student is felt to be at risk, the Child Protection and Safeguarding Policy will come into effect and social services will be contacted.
- 7.7 All accidents and incidents, including near misses or dangerous occurrences, will be reported as soon as possible following the school's Health and Safety Policy.

8. Searching

- 8.1 Staff members may use common law to search students with their consent for any item.
- 8.2 Staff members may ask any student to turn out their pockets.
- 8.3 Staff members may search any student's backpack or locker.
- 8.4 Under part 2, section 2 of the Education Act 2011, teachers are authorised by the headteacher to search for any prohibited item including, but not limited to tobacco and cigarette papers, as well as illegal drugs and alcohol, without the consent of the student if they have reasonable grounds for suspecting that the student is in possession of a prohibited item.
- 8.5 Searches will be conducted by a same sex member of staff with another same sex staff member as a witness, unless there is a risk that serious harm will be caused to a person if the search is not done immediately, and where it is not practicable to summon another member of staff.
- 8.6 Staff members may require a student to remove their outer clothing, such as coat, blazer, jacket, shoes.
- 8.7 Students' possessions will only be searched in the presence of the student and another member of staff unless there is a risk that serious harm will be caused if the search is not done immediately, and where it is not practicable to

summon another member of staff.

8.8 Staff members may use such force as is reasonable given the circumstances when conducting a search for alcohol, illegal drugs or tobacco products.

8.9 Any staff member, except for security staff, may refuse to conduct a search.

8.10 A staff member carrying out the search can confiscate anything they have reasonable grounds for suspecting is a prohibited item. This includes “legal highs” and other potentially harmful materials which cannot immediately be identified.

9. Staff Training

9.1 Holyhead School recognises that early intervention can prevent drug and/or alcohol misuse.

9.2 Teachers and support staff will receive regular and ongoing training as part of their professional development.

10. Monitoring and Evaluation of the Policy

10.1 The policy will be monitored and evaluated annually by the Deputy Principal and Vice Principal (Safeguarding and Wellbeing).
